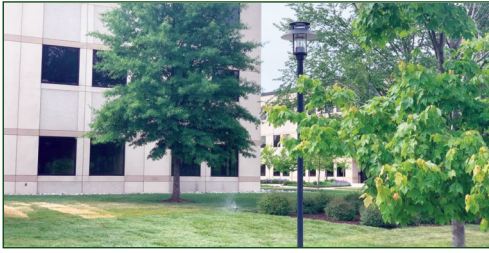


GO GREENE!
